Defendant Schell & Kampeter, Inc. ("Defendant") filed its Objections and Suggestions in Opposition to Plaintiffs' Proposed Class Notice and Class Methodology on January 31, 2023. Plaintiffs' Reply Suggestions in Support of Plaintiffs' Proposed Class Notice Plan was filed on February 17, 2023. The Court heard oral arguments regarding Plaintiffs' proposed class notice on May 1, 2024. Based on the Court's rulings during that hearing, Plaintiffs filed a revised proposed class notice form on May 9, 2024.

Being fully advised in the premises, and under Rule 52.08(c)(2), the Court finds Plaintiffs' proposed notice by publication is the best notice practicable under the circumstances. Accordingly, Plaintiffs' Proposed Class Notice Plan is **GRANTED**. The final class notice form approved by this Court for this case is filed contemporaneously with this Order. Plaintiffs shall implement their Class Notice Plan within thirty (30) days from the date of this Order.
